Exclusive Right of Burial Terms & Conditions:

The Exclusive Right of Burial is granted subject to the following terms and conditions:

- 1. Commencement of burial rights Council will not issue a Certificate of Exclusive Right of Burial and the Exclusive Right of Burial will not take effect until all applicable fees have been paid in full.
- 2. Proof of Ownership/Authority the Certificate of Exclusive Right of Burial constitutes proof of ownership of the Exclusive Right of Burial. Any person wanting to exercise any exclusive right granted in relation to a reserved plot must, when requested by Council, provide satisfactory proof of ownership; authority to act for and on behalf of the burial rights holder.
- 3. Burials cannot take place in the reserved plot unless prior written approval is obtained from Council by way of a signed Warrant of Interment.
- 4. General Obligations the burial right holder must comply with and observe all applicable statutes, regulations, by laws, New Zealand Standards and Council's direction in relation to the reserved plot.
- 5. Termination of burial rights The exclusive right of burial shall lapse if, at any time after the sale, 60 years pass without a burial taking place in that part of the cemetery or in that vault, brick grave, or place of burial which is the subject of such exclusive right (ref. Burial and Cremation Act 1964 section 10(4)). After that time, if no burial has taken place and the burial right holder chooses not to re-purchase the plot rights, the exclusive right of burial will revert to Nelson Council with no entitlement for refund of the purchase price.
- 6. Payment The applicant will be invoiced for the plot on receipt of the Application.
